INTRODUCTION

The Business Development Fund (the Fund) was established in 1991 as one of several initiatives undertaken by the Department of Economic Development and Tourism in response to the SCONE Report and the Government's Economic Strategy.

The intent was to consolidate various business related policies into one policy comprised of five programs designed to support business from concept to wind down.

PRIORITIES

During the first year the Department concentrated on developing client understanding of the programs, criteria and application procedures.

This past year focused on improving processing time through delegation of authority for some program components and ensuring consistent interpretation of the policy.

During the coming year amendments have been made to the policy to make it more responsive to client needs. Further administrative changes will result in improvement to the response times through further decentralized decision making and contribution processing.

PURPOSE

The Business Development Fund was created to promote economic growth throughout the Northwest Territories through diversification of the economy and the development of small business. It is designed to acknowledge the differences in investment opportunity and capacity between the communities with access to larger markets and the smaller, more traditional communities.

PRINCIPLES

The Fund is intended to fill the gaps in programs and services offered by other agencies. Even though it was designed as a last resort source of assistance, there are several underlying principles which govern the decision making process.

PROGRAM DESCRIPTION

Opportunity Identification and Research assists businesses to meet preestablishment or pre-expansion costs. This may include the cost of planning, legal help, engineering advice, feasibility studies, pilot projects or new product testing.

Business Creation, Expansion or Investment encourages the expansion and development of trade, services, renewable and manufacturing businesses through new business starts or expansions. Assistance is primarily directed to expansion related capital costs.

Market and Product Development assists businesses to generate and increase sales of NWT products, goods and services into new markets or to develop products for existing markets. Related costs include marketing, product development and the promotion of major events by NWT Societies.

Business Skills assists in management or business training.

Business Relief assists businesses in smaller or less developed communities in financial difficulty to identify problems and overcome them.

PROGRAM HIGHLIGHTS

1992/93 was the second year of the Department's delivery of the Business Development Fund. During the year a number of changes were introduced to address budget constraints and improve delivery time. They included reducing the maximum funding available under several schedules and delegating authority to the regions to approve contributions up to \$25,000 on Schedules B, C and D.

In 1992/93 the Department processed 313 applications totalling \$5,525,564, and approved 231 applications totalling \$2,757,185. While approvals increased by 4%, the volume was down by \$801,000.

Of these totals, the regions processed 151 applications totalling \$1,048,715 resulting in 123 approvals totalling \$622,371.




There was an overall decrease of 15% in total dollars distributed by the Fund from 1991/92 to 1992/93. In the main this was due to a weakness in the economy due to overall economic conditions in Canada. However, in part this was the result of reduced funding criteria. Although the total approved contributions decreased, approval for Group 2 communities increased. The BDF showed a 26% increase in dollars contributed to the Group 2 communities.


By Community Group - 1992/93 (\$000's)

APPENDIX A

SECTION 6 - SUCCESS STORIES

Canzeal Enterprises Ltd. operating as Fiberglass North, has been actively engaged in negotiations to manufacture and supply sewage and water tanks for the NWT Housing Corporation. A manufacturing plant complete with a ventilation system was required. Canzeal received a BDF contribution of \$48,000 and a loan from the Business Credit Corporation. They have become a significant employer of Yellowknives Dene Band members. The company was very successful in their first year of operations primarily due to their ability to meet very tight shipping deadlines for the construction season.


Delta Beaufort Micro Services, businessman lan Laws, created one fulltime and one parttime position with a \$21,600 BDF contribution and a WABDS loan. This firm offers computer acquisition services, installations and training. The business is growing steadily and doing well.

Charlines Ltd. received \$2,163 from the BDF to establish a bus tour operation in Cambridge Bay. They provide local community tours and bus tours towards Mount Pelly. It provides the tourist with an opportunity to view wildlife such as musk-ox, birds, flora and fauna. Two seasonal employees provide a service that is not otherwise offered in the area. They have had a very successful first season.


Senga Services accessed a \$25,000 BDF to establish a cable television system in Fort Simpson. The community now enjoys a much sought after northern luxury which provides them not only with entertainment, but a link to community activities and emergencies. The installation and set up phase provide employment equivalent to 1.5 person years. It continues to provide casual employment for the television technician. local bookkeeping and administration personnel. Their first year of operation has been very well received by the community.

Peteroosie Qappik of Pangnirtung had a word of mouth reputation for building boats. Over the years he had built a few of his own design. People started to ask if he could make one for them and he talked to his Economic Development Officer, Bruce Ashlev. Bruce put together a business plan and accessed \$6,000 from BDF plus a Baffin Business Development Centre loan. Together with his own equity, he bought tools and material and went into business for himself. This summer he met his target building three boats on his home deck, and the orders keep coming. This is a classic case of both creation of employment and import substitution as most of Pangnirtung's boats were imported from Manitoba at a much greater cost than *Qappik's*. The \$6,000 in BDF funding has already been returned in the form of additional wages to the community.

In December, 1992, Roland Tungilik applied for assistance to establish First Taxi in the community of Repulse Bay. Roland already owned a vehicle and required assistance to purchase a prefabricated garage to house the vehicle in winter months, plus insurance for the initial 6 month period. First Taxi received a BDF contribution of \$1422 and began service in January, 1993. In its first 6 months of operation it has surpassed its forecast revenues. Prior to First Taxi opening, the community had no public transportation service. The community has shown its support in the consistent utilization of First Tax's services.


