(3) SPEAKER: annual figure of \$25,000 for Speaker.

(4) SPECIAL ANNUAL INDEMNITIES FOR EXTRA DUTIES: Deputy Speaker: \$5,000; Deputy Chair, Committee of the Whole: \$3,000; Chair of Standing Committee: \$3,000.

(5) CAPITAL LIVING ALLOWANCE: Annual figure of \$5,500 for Members who live within commuting distance of Yellowknife; \$8,500 for all other Members; Ministers are considered to live in Yellowknife and receive \$5,500.

(6) NORTHERN ALLOWANCE: Annual amount paid in respect of the community in which Members live. Same as provided under the Collective Agreement. Tabled pursuant to Section 35(a) of the Legislative Assembly & Executive Council Act.
