These students and others work together in classes of approximately 25 students - class size limits at most grades are higher, so if more students, with whatever needs, move into our community, the classes will grow. Due to financial constraints, few educational assistants are hired, except in extreme cases. I am the only special needs assistant currently working at our school. Due to financial constraints, there is less teacher time available for small group student support or individual tutoring.

Our students need to be given a solid foundation of skills in all subject areas, but especially in reading and math, yet are able to receive very little individual attention, as teacher time must be divided among so many with such divergent needs. All students suffer as a result of the increased demands made on my time and energy.

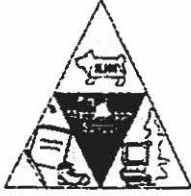

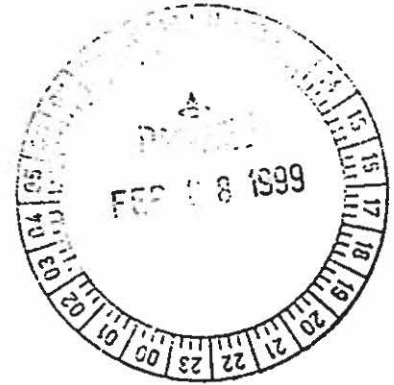
