I look forward to hearing from you or for a possible meeting with you in the near future in regards to the issue.



DENE NATION LEADERSHIP MEETING YELLOWKNIFE, NWT DECEMBER 3-7, 1984

WHEREAS the land itself and streams, lakes and other landmarks in Denendeh are known to the Dene by Dene names and;

WHEREAS the Government of Canada and the Government of the Northwest Territories have violated Dene tradition, Dene culture and the Dene right to self-government by giving non-Dene names to landmarks in Denendeh and;

WHEREAS the recent "naming of the Western NWT" contest has caused some confusion about the future name of Denendeh;

THEREFORE BE IT RESOLVED THAT:

1. That the Dene Nation affirms its commitment to Denendeh as the name of our homeland and instructs the Executive to inform the Government of the N.M.T. of this commitment.

- That in conjunction, with the Dane Mation, the government of the N.M.T. immediately establish a public commission with a jority Done Nembership to implement the following objectives:
 - a) Giving appropriate Done names to presently unnamed landmarks and to give Done names to all new roads, public buildings and places in Donendeh.
 - b) Systematically and officially recognizing and renaming, with Dene names, all landmarks roads, public buildings and places now known by English names.

DRAFT MOTION RE: NAME FOR A NEW WESTERN TERRITORY

WHEREAS the Dene Leadership has discussed the need to name a new western territory; and

WHEREAS the Dene Leadership feels strongly that a native name should be chosen for a new western territory, since a majority of the residents of the new territory shall be native; and

. WHEREAS the western part of the N.W.T. is, for the most part, the traditional and continuing homeland of the Dene; and

WHEREAS the Dene continue to be the rightfull owners and managers of the Dene homeland; and

WHEREAS the Dene have, through a process of community consultation and discussions over the past several years, and taking into account the five Dene languages, chosen-Denendeh (Land of the People) as the name for our homeland; and

WHEREAS the Dene believe that naming the new western territory Denendeh would be a positive step in recognizing the Dene heritage and the rightful place of the Dene as full participants in the shaping of our future;

THEREFORE BE IT RESOLVED that the Dene leadership strongly affirms its position that the name for a new western territory should be Denended in recognition of the existence of the Dene in this part of the north since time inmemorial and in recognition of our future role as full participants in a new government in the new western territory.

DENE LEADERSHIP MEETING FORT SIMPSON, N.W.T. SEPTEMBER 21,22,23, 1987

Re: Support for Division and W.C.F. Constitutional Process and Iqualuit Agreement

WHEREAS the Dene people have supported the inuit in their demands for an inuit Territory called Nunavut; and

WHEREAS the Dene continue to support changes to the present Territorial Government structure to make the government more reflective of the Dene method of governing, which include our culture and values; and

WHEREAS the creation of a new government structure sensitive to the Dene with specific aboriginal guarantees is an integral part of the claims strategy and represents the political part of the claim; and

WHEREAS the Dene have supported the process called the WCF or Western Constitutional Forum which has been established to negotiate the division of the N.W.T. and the creation of Nunavut and Denendeh and which will contain these political guarantees; and

WHEREAS the W.C.F. and N.C.F. (Nunavut Constitutional Forum) have negotiated the January 87 iqualuit Agreement which establishes a timetable for division, a process to negotiate the structure of the two new governments and recommends that the division boundary be the <u>RATIFIED</u> claims boundary yet to negotiated and ratified by the Dene and Metis;

NOW THEREFORE BE IT RESOLVED that this Leadership reaffirms its support for the creation of Denendeh in the Western part of the N.W.T.; and

FURTHER BE IT RESOLVED that this Leadership reaffirms its support for the January 87 Iqualuit Agreement with the same condition that the division boundary be a RATIFIED claims boundary; and
