Dear Mr. Evaluajuk,

The Baffin Regional Health and Social Services Board need your support in obtaining financial commitment from the Government of the Northwest Territories to build a new Health Facility in Iqaluit.

As you know, Health and Social Services are amalgamating as we speak. The new Health Facility is not going to be only a hospital, but a place where people go to get help in health problems, social work, to gain information to stay well, family planning, mental health clinic and public health.

Our old hospital is functioning, but it is outdated and two small. It can no longer function as well as it did. The population has more than doubled in the last thirty-five years. It is getting more difficult to keep up with technology in the old building.

The Baffin Regional Health and Services Board believes in good faith in the agreements. The agreement in 1988 said we will get a new hospital. That agreement cannot be broken and forgotten about.

At our last board meeting, we passed a motion, unanimously to form a foundation. This foundation is in the process. A report will be presented in our November board meeting. This foundation will be able to fund raise more aggressively.

Iqaluit is the capital of Nunavut. There will be more people moving here before 1999. All these extra people will need health and social services.
