Closure of Rainbow Child Care and Development Centre

Thank you for your e-mail of Monday, September 27, 2005, in which you indicate the Rainbow Child Care and Development Centre would close on Friday, September 30, 2005. I understand from your news release of October 13, 2005, that the Centre will be closing as of October 28, 2005.

As you are aware, the Department of Education, Culture and Employment's (ECE) Early Childhood Program provides support funding to licensed non-profit programs based on the actual attendance of children in the program. These payments are provided to programs following the quarterly submission of daily attendance records.

During our recent telephone conversation, you raised the issue of changing the manner in which early childhood programs are funded. As I indicated, the Department has no plans to change the way in which these programs are funded through the Early Childhood Program.

I understand that at this time the Rainbow Child Care and Development Centre has received all of the funding for which it is eligible from the Early Childhood Program. I encourage you to contact the Regional Office in Fort Smith should you have questions on the status of funding or reporting requirements pertinent to ECE support for the Rainbow Child Care and Development Centre.

Re: Closure of daycare centre

As the Rainbow Child Care and Development Centre will be closing on October 28, 2005, Aurora College Thebacha Campus staff will require all keys to the facility from you at 5 p.m. on that day, and our lease with the society will terminate at that time on that date.

Should you require further access to the building after that point, you must be escorted by an Aurora College staff member.

As to your letter of October 18, we appreciate the information, but are well aware of the challenges our students face regarding childcare, having already helped them find care for their children when your facility failed to open in September of 2003.

The College has a proven track record of supporting our students in their search for quality child care, as is evidenced by our provision of free daycare space in the Green House in the 1990s, and in the facility which you currently occupy. We are confident we will be able to support them in overcoming any challenges resulting from your closure of the daycare, and are pleased to note that four of our students have already made satisfactory alternate arrangements.

I note that you indicate in your letter that you will sell off any daycare assets in order to cover the debt you have incurred. Please be aware that some of the materials in that building are the property of Aurora College, and that we will require a full inventory of the assets you intend to sell.

Thank you for your efforts related to the daycare.
