Medical Supply Purchases

In response to your letter of September 21, 2005 I would like to first state that all of the information you requested is not readily available from the Health Authorities in the format or detail that you requested. However, understanding the concern you raised. I am providing information that I believe will meet your needs.

What is the total budget for individual suppliers for the GNWT and Health Boards? Would you provide a breakdown of those figures?

The Authorities do not budget by supplier. In an attached document I have provided you with the annual budget for Medical Surgical Supplies for the Authorities and the Department's EHB program.

Which medical supply companies (Name and Head Office location) are most frequently used by the GNWT, please provide the amount each company receives?

I have attached a document that provides details on the 2004/05 expenditures. which indicates supplier, status as north or south, and amount spent by authority. Not all Authorities have provided this breakdown, however, the major users of medical surgical supplies have been captured.

Would you please clarify the reasoning behind any medical supply purchases that do not go to public tender and whether there is a policy in place categorizing medical supplies as either open to tender or sole sourced?

There is no policy that categorizes medical supplies any differently from any other good or service purchased by the GNWT.

The Authorities are required to follow GNWT procurement processes, specifically:

- FED 0 % 2005 Purchases under \$1,000 are to be made from BIP registered suppliers when available, tendering is not required,
- Purchases between \$1,000 and \$5,000 are to be made by informal tenders from at least three suppliers, if available.
- Purchases over \$5,000 are to be made by formal tender.

In gathering this information the Department has determined that the degree of compliance with the GNWT's purchasing policies varies. Some Authorities appear to comply, others have misinterpreted the policy and others do not appear to comply.

Would you also provide a breakdown of those items sole sourced out to southern companies?

This request requires extensive manual investigation by Authority staff as their financial systems, nor GNWT financial systems maintain information in this manner. In light of the need to respond to you in a timely fashion, we did a more detailed review of southern purchases made by Stanton Territorial Hospital and a preliminary analysis indicates that over half of those purchases are made without tenders.

The Deputy Minister will be talking about this issue with the CEO's at a meeting being held this week. I have also directed the Department to investigate this further with the view to assist the Authorities to comply with GNWT procurement policies.

I will provide you with an update prior to the next session.
