Dear Mr. Roland,

As the former Student Counsellor and in my current position as Director of Student Services at Aurora Campus in Inuvik, I have had the opportunity to work on the front lines of community wellness, and healthy lifestyle behaviour development with help from the staff of Delta House. The recent announcement to close Delta House will be a great loss to our department and to this community. Delta House staff have helped our campus in several ways.

Some of the help we have received and still receive from Delta House includes but is not limited to:

-Delts flouse is a referral agency that we use to provide alcohol and drug counselling to students who request it.

-Delta House helps us promote healthy lifestyle choice behaviours by participating in our continuing campaigns to encourage our students to live alcohol and drug free lifestyles. Last year our campus won a national award for its participation in National Collegiate Alcohol Awareness Week with the help of organizations like Delta House.

This is a much needed service that has naturally developed because of our close working relationship with Delta House staff. -Delta House also offers programs in the evenings that staff and students participate in to help them deal with their problems.

go through Fist Losing a community institution like Delta House, which has gained the respect and confidence of the community of Inuvik, will definitely increase our work load, Losing Delta House will also impact on our ability to effectively refer people who have D& A problems to an outside agency that has the property trained staff and progrums.

In conclusion, I would like to say that it is a sud day in the Delta when an organization like Delta House, which works at the front lines of community wellness development, closes. At this campus we recognize the need for Alcohol and Drug rehabilitation as we face this difficult social disease on a rather continuous basis because of several factors. Alcohol and drug abuse affects the very heart of our community and greatly limits the ability for the North to necome self-reliant as it affects our youth and generations to come.

is community wellness a priority with our elected officials?

is the North's future and its people important to our leaders?

If the answer is yes to the shove then Delta House is a leader in education, healing, and awareness in the continual challenge of forging towards community wellness as it relates to one of our most serious problems - alcohol and drug abuse.
