




Fifteenth Annual Report for Fiscal Year Ending June 30, 1997

In January 1979 at Rankin Inlet, Ted Richard, (now Justice J.E. Richard) and Kathy Peterson defended Barrington Clive Campaugh on charges including attempted murder before Mr. Justice Calvin F. Tallis sitting with a jury. Here is Ted Richard with his expert witness psychiatrist Dr. Arboleda-Florez of Calgary. For a variety of reasons, Dr. Arboleda-Florez could not be called to give evidence at the trial. You can see he was underdressed for the -60°C temperatures and brisk winds which prevailed throughout the 10 day trial.

Chairman's Report

To: The Legislative Assembly of the Northwest Territories; and

To: The Executive, Law Society of the Northwest Territories.

As required by the Legal Profession Act, I submit for your consideration the 1997 Annual Report for the Law Foundation.

The Foundation is experiencing reduced income due to the general decline in interest rates, with a concomitant reduction in trust account earnings. The Foundation has significant investments the income of which has enabled it to continue the grant and Bursary program without reduction. However, the Board is cognizant of the need to be mindful of the reduction in revenues, therefore grants and bursaries may well have to be reduced accordingly in order for there not to be a significant encroachment on the Foundation's capital.

The manner in which the capital of the Foundation should be invested has been the subject of some discussion by members of the Society as well as the Board. It was determined by resolution of the Board that the advice and assistance of Wood Gundy (Canadian Imperial Bank of Commerce) would continue to be sought, but the investments should be conservative in nature. In other words, restricted to government guaranteed securities.

The Division of the Territories in 1999 is a matter of interest and concern for the Board, as it will in all likelihood entail the eventual division of the assets of the Foundation. What ultimately occurs will of course primarily depend upon the form the legislation takes, which is the decision of others. The Board intends to make known its views to the law makers.

The Northwest Territories Law Foundation/Graeme Garson Bursary Fund awarded scholarships in the amount of \$2500.00 each to: Naomi Nind, Yellowknife, Sarah McDermott, Iqaluit and Mark Himmelman of Iqaluit.

The Board is pleased and honored that Dennis Patterson, former Government Leader and long time Member of the Legislative Assembly for Iqaluit, accepted the appointment as the lay member of the Board. I am grateful for the contribution not only of Mr. Patterson but Sue Cooper, Ed Gullberg and John U. Bayly, the other members of the Board.

Reg Tolton Chairman The Northwest Territories Law Foundation was established pursuant to Part VII of the Legal Profession Act for the purpose of receiving the interest which banks must pay on client's funds held by lawyers in mixed trust accounts. It is similar in form to Law Foundations established in most provinces.

Objectives

The objectives of the Law Foundation are to use the funds collected in this manner to provide funding in the following areas:

- (a) conducting research into and recommending reform of the law and the administration of justice;
- (b) establishing, maintaining and operating law libraries;
- (c) contribution to the legal education and knowledge of members and the people of the Northwest Territories and providing programmes and facilities therefore;
- (d) providing assistance to legal aid programmes and programmes of like nature;
- (e) contributing to the Assurance Fund; and
- (f) doing all other things that, in the opinion of the Directors, are incidental or conducive to the attainment of these objects.

Administration

The Foundation is administered by a Board of Directors consisting of five members; four being members of the Law Society and appointed by the Executive of the Law Society and one who is not a member of the Law Society and who is appointed by the Commissioner. The Directors serve for a term of two years.

The Directors meet as required to decide on policy matters and to deal with the general administration of the Foundation including policy as to the collection and investment of funds. A "grant meeting" is held once per year to consider all requests for funding for that fiscal year.

Administration and management services are provided through an Executive Manager who is engaged on a contract basis.

Scholarship

The Northwest Territories Law Foundation/Graeme Garson Bursary Fund has funds available to assist law students in pursuing legal studies at either the graduate or undergraduate levels.

Application deadline is March 15th.

NWT Law Society \$12,000.00



At the Rankin Inlet jury trial of Barrington Clive Campaugh in Rankin Inlet January 1979, the late George Mitchell was the Court Reporter. One of the last of the Puttman shorthand reporters to work in the Northwest Territories, George began his career as a Court Reporter in Ontario in October 1929. He took a shorthand record of proceedings at the Nuremberg war crimes trials after World War II. He came to live and work in the Northwest Territories as a Court Reporter after his retirement in Ontario.

Auditor's Report

To the Board of Directors of Northwest Territories Law Foundation

I have examined the balance sheet of the Northwest Territories Law Foundation as at June 30, 1997 and the statements of revenue and expenditure and members' equity for the year then ended. These financial statements are the responsibility of the Law Foundation's management. My responsibility is to express an opinion on these financial statements based on my audit.

I conducted my audit in accordance with generally accepted auditing standards. Those standards require that I plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used in significant estimates made by management, as well as evaluating the overall financial statement presentation.

In my opinion, financial statements present fairly, in all material respects, the financial position of the Law Foundation operations as at June 30, 1997 and the results of its operations for the year then ended in accordance with generally accepted accounting principles.

Notes to Financial Statements

Year ended June 30, 1997

1. Significant Accounting Policies

The foundation is incorporated under the statutes of the Northwest Territories, and carries on the activity of conducting research, establishing law libraries and contributing to the legal education and knowledge of members and the people of the Northwest Territories.

- (a) The foundation records revenue from interest on members trust accounts as received and deposited from members of the Law Society of the Northwest Territories.
- (b) The foundation records all unpaid approved grants as payables.
- (c) The cost method is used in accounting for the portfolio investments. In the case of fixed term securities, the foundation is amortizing the discount over the period to maturity. The carrying value of the investment is adjusted systematically, during the period it is held, towards the amount expected to be realized at maturity or an earlier call date.

2. Bursary Fund

A bursary fund of \$100,000 was established to generate interest income to finance a scholarship program for law studies.

The funds have been combined into the investment account and the interest portion relating to the bursary fund is calculated at year-end.

3. Committed Funds

The foundation has committed an amount of \$7,500 for Scholarships to assist law students in pursuing legal studies, the amount that is actually payable is not determinable at this time.

4. Statement of Changes in Financial Position

A statement of changes in Financial Position has not been prepared as it would not provided any additional meaningful information.
