Dear Mr. McLeod,

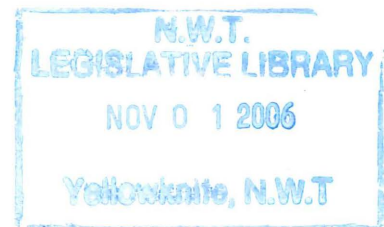
